LOUISIANA SECRETARY OF STATE'S OFFICE ISSUES CALL FOR VOTING SYSTEM AND COMPONENT CERTIFICATION

BATON ROUGE, La.— Louisiana Secretary of State Nancy Landry invites all parties seeking to have a voting system or system component certified by the State of Louisiana per recently issued standards, <u>viewable here</u>, to apply for upcoming certification opportunities.

According to Act 480 of the 2021 Regular Legislative Session, certification of a voting system or system component is a required step in order to be eligible to receive a procurement contract for Louisiana's voting system.

Certification will take place at the Louisiana Old Governor's Mansion, located at 502 North Blvd. in Baton Rouge, during the following periods:

- July 28-Aug. 1
- Aug. 25-27
- Sept. 8-12
- Sept. 15-19

Interested parties must apply using this link no later than July 11, 2025. Once the application, documentation, and application fee are received, the Secretary of State's Office will contact the applicant to arrange certification testing dates, based on availability. The fee is \$7,000 for system certification or \$3,500 for a single system component.

Vendors with questions should contact electionvendors@sos.la.gov. Members of the public will have the opportunity to view the certification testing.

QUALIFYING PROCEDURES FOR OCT. 11 OPEN PRIMARY/ORLEANS MUNICIPAL PAROCHIAL PRIMARY ELECTION

July 8, 2025

BATON ROUGE, La. — Qualifying for the Oct. 11, 2025 Open Primary/Orleans Municipal Parochial Primary Election will take place Wednesday, July 9 through Friday, July 11.

All local candidates must qualify with their parish Clerk of Court. Candidates may qualify for office by paying a qualifying fee or filing a nominating petition and are encouraged to check with their local Clerk of Court for specific parish hours. More information, including contact information for parish Clerk of Court Offices, can be found by visiting GeauxVote.com and selecting the Election Qualifying link. Once qualified, candidates will appear on the Secretary of State's website at www.sos.la.gov.

Pursuant to Louisiana Revised Statutes 18:461 and 18:463, qualifying candidates will be required to provide an email address and present a valid Louisiana driver's license or Louisiana identification card. The email address provided will be listed on the Secretary of State's website.

Secretary Landry announces passage of voter protection bills

SECRETARY OF STATE NANCY LANDRY ANNOUNCES PASSAGE OF VOTER PROTECTION BILLS

June 13, 2025

BATON ROUGE, La.—Louisiana Secretary of State Nancy Landry is proud to announce the passage of multiple legislative instruments in the Department of State's Voter Protection Package during the 2025 Regular Legislative Session.

"I am exceedingly grateful to the authors and sponsors of the bills in our Voter Protection Package and the members who supported those pieces of legislation," Secretary Landry said. "Thanks to them, four instruments from our legislative slate passed overwhelmingly, all with bipartisan support. These instruments will help Louisiana continue on the path to being ranked first in the nation in election integrity. I thank Governor Landry for signing several of these bills into law, and I look forward to working with him to ensure the remaining instruments become law."

The department's package of bills that were passed are:

- SB 90 by Senator Rick Edmonds: Bans wagering on elections
- HB 206 by Representative Michael Melerine: Requires legislative approval of election-related consent decrees
- HB 351 (Act 80) by Representative Mike Johnson: Assesses court costs and attorney's fees for knowingly attesting to false information in a Notice of Candidacy
- SCR 35 by Senator Rick Edmonds: Calls for a procedural election audit by the Louisiana Legislative Auditor every four years

The contents of SB 109 by Senator Alan Seabaugh and HB 590 by Representative Annie Spell, which bans foreign funding of election contests and ballot measures, were amended into Representative Mark Wright's HB 693.

Louisiana becomes first state to utilize new voter list maintenance database

LOUISIANA FIRST STATE TO UTILIZE NEW VOTER LIST MAINTENANCE DATABASE

May 21, 2025

BATON ROUGE, La. — Louisiana has become the first state to utilize a new voter list maintenance database from the federal Department of Government Efficiency. This database combines information on individuals' immigration status and death records.

"Since taking office, I have repeatedly requested this critical data from the federal government to check Louisiana's voter registration list," Secretary of State Nancy Landry said. "After being stymied by the previous administration, I am thankful to President Trump for his quick work in crafting a cost-free, user-friendly database with valuable information that will help keep Louisiana's voter rolls accurate. Clean voter rolls are critical to the integrity of our elections."

Secretary Landry discussed and offered feedback on this new database with White House staff, the Department of Government Efficiency, U.S Citizenship and Immigration Services, and the Social Security Administration at recent meetings in Washington, D.C. Additionally, after being vetoed three times by Governor John Bel Edwards, Act 2 of the 2024 Regular Legislative Session took effect this year and will allow for expanded voter list maintenance through mailed confirmation cards to individuals who have not voted or had contact with election offices in ten or more years.

Secretary Landry announces voter protection measures for the 2025 Regular Legislative Session

SECRETARY LANDRY ANNOUNCES VOTER PROTECTION MEASURES FOR THE 2025 REGULAR LEGISLATIVE SESSION

April 9, 2025

BATON ROUGE, La.— Louisiana Secretary of State Nancy Landry announced the Department of State's 2025 voter protection package for the upcoming legislative session.

"Louisiana is ranked second in the nation for election integrity due, in part, to legislation our office has championed over the years. However, I won't be satisfied until we are number one," Secretary Landry said. "This package of bills will move us even closer to that goal. I appreciate all of the legislators who have worked with us to bring this legislation for the upcoming regular session."

The Department's bill package includes:

- SB 109 (Constitutional Amendment) by Senator Alan Seabaugh to ban foreign funding of candidates or ballot measures
- SB 90 by Senator Rick Edmonds to ban wagering on elections
- HB 206 by Representative Michael Melerine to require legislative approval of consent decrees signed by the Secretary of State on certain election matters
- HB 351 by Representative Mike Johnson to assess court costs and attorney's fees for knowingly attesting to false information in a Notice of Candidacy
- HB 590 by Representative Annie Spell to statutorily enforce a ban on private funding in election administration and foreign funding of candidates or hallot measures.
- HB 223 by Representative Jessica Domangue to increase election commissioner pay
- · An SCR by Senator Rick Edmonds to call for a procedural election audit by the Louisiana Legislative Auditor every four years

The 2025 Regular Legislative Session begins April 14. MAY 3 ELECTION REMINDERS

April 1, 2025

BATON ROUGE, La. — Secretary of State Nancy Landry reminds voters that Saturday, May 3 is Election Day for the Municipal General and Special Primary Election for State Representative in the 67th Representative District.

In preparation for the election, Secretary Landry encourages voters to remember:

- The deadline to register to vote in person, by mail, or at the OMV Office is April 2.
- The deadline to register to vote through the GeauxVote Online Registration System is April 12.
- Early voting is April 19 26 (excluding Sunday, April 20) from 8:30 a.m. to 6 p.m. Early voting locations can be found at voterportal.sos.la.gov/earlyvoting.
- The deadline to request an absentee ballot is April 29 by 4:30 p.m. (other than military and overseas voters). Voters can request an absentee ballot online through the Voter Portal or in writing through the Registrar of Voters Office.
- The deadline for a voter to return a voted absentee ballot to their parish's Registrar of Voters Office is May 2 by 4:30 p.m. (other than military and overseas voters).
- Due to unpredictable mail delivery speeds, absentee voters utilizing the United States Postal Service are encouraged to allow additional time for their ballot to reach its destination.
- Polls open at 7 a.m. and close at 8 p.m. on Election Day. Anyone in line at 8 p.m. will be allowed to vote.
- Voters can find their polling location and sample ballot by downloading the GeauxVote Mobile app for smartphones, or by visiting www.GeauxVote.com and logging into the Voter Portal.
- Voters are encouraged to sign up for electronic notifications via GeauxVote Mobile.
- Voters should bring an ID with them to vote (Louisiana driver's license, Louisiana Special ID card, a generally recognized picture identification card with name and signature such as a passport, or a digital license via LA Wallet).
- Election results can be viewed in real-time via GeauxVote Mobile or at www.sos.la.gov.

The deadline to **request** an absentee ballot is **Tuesday, April 29 by 4:30 p.m.** Requests can be made online by visiting voterportal.sos.la.gov and selecting "Request Absentee Ballot," or in person at the parish Registrar of Voters Office. Voters who have requested but not yet received an absentee ballot may check their absentee ballot status by visiting voterportal.sos.la.gov, entering the appropriate voter information, and selecting "Check Absentee Ballot Status."

The deadline to **return** a completed ballot is **Friday, May 2 by 4:30 p.m**. Due to unpredictable mail delivery speeds, absentee voters utilizing the United States Postal Service are encouraged to allow additional time for their ballot to reach its destination. Should a voter be unable to meet an absentee ballot deadline, they can still vote in person on Election Day. Polling locations can also be found on voterportal.sos.la.gov or on the free GeauxVote mobile app.

Absentee voters should be aware of new laws that took effect after the 2024 Regular Legislative Session. Based on those new statutes, an individual may assist a voter with their absentee ballot and deliver an absentee ballot for:

- Any immediate family members; and
- One non-immediate family member.

Immediate family member is defined in statute as "the individual's children, the spouses of his children, his brothers and their spouses, his sisters and their spouses, his parents, his spouse, and the parents of his spouse."

Secretary Landry issues statement on President Trump's Executive Order

SECRETARY LANDRY ISSUES STATEMENT ON PRESIDENT TRUMP'S EXECUTIVE ORDER

March 26, 2025

BATON ROUGE, La. — Louisiana Secretary of State Nancy Landry issued the following statement regarding President Trump's Executive Order on Preserving and Protecting the Integrity of American Elections:

"I thank President Trump for his recent executive order concerning the security of our elections. By directing agencies under his purview to provide critical data regarding immigration, illegal non-citizen voting, and the Social Security Administration's Death Index, our state will have the crucial tools it needs to further ensure that our voter rolls are accurate.

Further, by reforming how the Election Assistance Commission lists citizenship requirements on its national voter registration form, our state will more quickly be able to implement and enforce Act 500 of the 2024 legislative session.

I believe this executive order respects the states' Constitutional authority to administer elections, per Article I, Section 2, while requiring the federal government to give the states the tools they need to keep our elections safe and secure."

This executive order comes the same week that The Heritage Foundation announced that Louisiana is ranked second in the nation on its updated Election Integrity Scorecard.

Louisiana ranked second in the nation for election integrity

LOUISIANA RANKED SECOND IN THE NATION FOR ELECTION INTEGRITY

March 24, 2025

BATON ROUGE, La. — Secretary of State Nancy Landry announced that Louisiana is now ranked second in the nation for election integrity by the Heritage Foundation after previously being ranked ninth by the same group. Scores are calculated from 12 different categories, including voter ID implementation, absentee ballot management, vote counting practices, and verification of citizenship.

"This latest ranking proves once again that Louisiana's elections are safe and secure," Secretary Landry said. "I am proud of the hard work that our elections team does day in and day out to ensure the integrity of our elections. While this news is cause for celebration, there is still much work to be done. I won't be satisfied until Louisiana is number one in the nation, and I am confident that will happen when we transition to a new, fully-auditable voting system."

The Department of State has begun the process of procuring a new voting system, and Secretary Landry has indicated that the agency will secure one within the year.

Secretary Landry announces successful follow-up audit

SECRETARY LANDRY ANNOUNCES SUCCESSFUL FOLLOW-UP AUDIT

March 17, 2025

BATON ROUGE, La.—The Louisiana Legislative Auditor (LLA) conducted a follow-up to their award-winning 2021 audit of the Louisiana Department of State's election integrity procedures. The original report found "[overall]...DOS has procedures and practices to ensure election integrity." The follow-up concluded that the agency has implemented or is in the process of implementing all recommendations made in the 2021 audit.

"I appreciate the thorough work of Louisiana Legislative Auditor Michael Waguespack and his team," Secretary Landry said. "This latest report confirms what the voters of our state know to be true: Louisiana's elections are safe, secure, and accurate. I look forward to continuing to strengthen our policies and procedures to make us number one in the nation for election integrity."

LLA made five recommendations in its 2021 audit. The follow-up report found that the Department of State implemented three (ensuring documentation of test vote results, formal documentation of post-election verification activities, and consistent categorization of complaints to the Division of Election Integrity) and is in the process of implementing two (additional state-by-state data matches and post-election audits). It further found that legislation was enacted relating to six matters for legislative consideration, including:

- Act 2 (2024): The adoption of an expanded annual voter canvass to ensure an accurate voter registration list.
- · Act 321 (2024): The establishment of uniformity on what information is required for absentee by mail ballots.
- Act 639 (2022): The development of rules to create uniformity for what absentee by mail ballots are referred to the Parish Board of Election Supervisors.
- Act 572 (2022): The requirement of a signed certification of voting machine testing.
- Act 741 (2022): The adoption of uniform policies and procedures for the conduct of a post-election tabulation audit of paper records.
- Act 640 (2024): A provision for six weeks between primary and general elections beginning in 2026.

- · not be under a judgment of full interdiction for mental incompetence or partial interdiction with suspension of voting rights;
- be a resident in the state and parish in which they seek to register and vote;
- apply at least 20 days prior to an election if registering online or 30 days prior to an election if registering in person or by mail.

Citizens with a valid Louisiana driver's license or Louisiana Special ID card can register online 24 hours a day, seven days a week by visiting https://voterportal.sos.la.gov. Louisiana residents can also register in person at their parish Registrar of Voters Office, when they apply for or renew their driver's license at any Office of Motor Vehicles, or when obtaining services at public assistance agencies and Armed Forces recruitment offices.

Louisiana civil rights leader Johnnie Jones named Margaret Chase Smith American Democracy Award recipient

LOUISIANA CIVIL RIGHTS LEADER JOHNNIE JONES NAMED MARGARET CHASE SMITH AMERICAN DEMOCRACY AWARD RECIPIENT

July 19, 2024

BATON ROUGE, La. — Secretary of State Nancy Landry is pleased to announce that Louisiana native Johnnie Jones, a veteran of the Second World War and key figure of the Civil Rights Movement, has been posthumously named the 2024 Margaret Chase Smith American Democracy Award winner. Jones was named the recipient of this prestigious honor on Friday, July 12 at the National Association of Secretaries of State (NASS) Summer Conference in Puerto Rico. NASS members recognize award recipients for individual acts of political courage, uncommon character, and selfless action in the realm of public service.

A native of Laurel Hill, Louisiana, Jones was drafted into the U.S. Army when the United States entered the Second World War and took part in the Normandy Invasion as part of the 494th Port Battalion. He was wounded aboard the SS Francis C. Harrington when it struck a mine and then came under fire from German aircraft. Despite his injuries, Jones continued to fight for the liberation of France, fought in the Battle of the Bulge, and served as an aide to General Dwight D. Eisenhower. He was awarded a Purple Heart for his injuries sustained in combat at a ceremony in 2021 at Louisiana's Old State Capitol.

When Jones returned home from war, he was beaten by a police officer on his way to a medical appointment to care for his injuries. This compelled him to pursue his law degree at Southern University Law Center. After graduating from law school in 1953, Mr. Jones was asked to represent protestors and members of the United Defense League who were participating in the Baton Rouge Bus Boycott. This protest became the blueprint for the Montgomery Bus Boycott. He continued to serve as a civil rights activist as a member of the Louisiana House of Representatives, and after his one term in office, he returned to practicing law until the age of 93. Jones passed away at the age of 102 in 2022.

"I was pleased to nominate Mr. Jones for this prestigious award and am honored that my colleagues have seen fit to name him as this year's award recipient," Secretary Landry said. "From his service on the beaches of Normandy, to the Baton Rouge Bus Boycott, to his time in the state capitol, Mr. Jones spent his life fighting for what he believed in and represented the very best of Louisiana."

Previous award recipients include Rosa Parks, the Little Rock Nine, former U.S. Secretary of State Dr. Condoleezza Rice, and former U.S. Supreme Court Justice Sandra Day O'Connor.

- · SB 218 (Now Act 317) by Senator Caleb Kleinpeter: Restricts the unsolicited distribution of absentee ballot applications
- · SB 226 (Now Act 321) by Senator Heather Cloud: Creates uniform standards for tabulating absentee ballots
- SB 436 by Senator Mike Fesi: Allows the Secretary of State to require proof of United States citizenship when registering to vote

All candidates for state office will qualify at the Louisiana State Archives located at 3851 Essen Lane in Baton Rouge. Hours of operation for the secretary of state are 8 a.m. until 4:30 p.m. daily. Candidates are encouraged to check with their local clerk of court for specific parish hours.

Pursuant to Act 312 of the 2020 Regular Session and Act 35 of the 2022 Regular Session, qualifying candidates will be required to provide an email address and present a valid Louisiana driver's license or Louisiana identification card. "Though I am disappointed in the lenient sentence, I am grateful that this matter is finally resolved, and that Mr. Ruffino will now forever be recognized as a convicted felon who should not be involved in elections," Ardoin stated. "I applaud the Department of State's Elections Compliance Unit investigators for their diligent work to support federal investigators in the quest to bring all individuals in this illegal vote-buying conspiracy to justice."

Last year, former Amite City Chief of Police Jerry Trabona and Amite City Councilman Kristian Hart were each sentenced to one year in prison for conspiring to pay, or offering to pay, voters for voting in a federal election. Ruffino was sentenced to one year of probation for his involvement in the scheme.

BATON ROUGE, La. — Following the conclusion of the 2023 Regular Session of the Louisiana Legislature this week, Louisiana Secretary of State Kyle Ardoin issued the following update on the Department of State's legislative package:

"I am grateful to the legislature for passing instruments included in our agency's legislative package, and I am especially thankful to the members who carried these bills and worked so hard to ensure their passage. I call on Governor Edwards to swiftly sign these unsigned bills into law so that we can continue to improve upon our stellar election integrity measures," Ardoin said. "Louisiana voters will also have the opportunity to vote on a constitutional amendment to ban the private funding of elections in October, thanks to Representative Blake Miguez's HB 311."

Selected bills that were part of the department's package include:

- HB 311 by Representative Blake Miguez, which would amend the constitution to ban the private funding of elections in Louisiana (This bill does not require the Governor's signature).
- HB 646 by Representative Les Farnum, which would make improvements to the annual voter canvass to improve the accuracy of Louisiana's voter rolls.
- HB 135 by Representative Mike Johnson, which would ban sex offenders from serving as election commissioners (This bill passed the legislature unanimously).
- HB 216 by Representative Dodie Horton, which will allow members of the military stationed in Louisiana, and their dependents, to serve as election commissioners (This bill has been signed into law and is now Act 18).
- HB 361 by Representative Daryl Deshotel, which would ban TikTok on state-owned devices and networks (This bill passed the legislature unanimously).

"Louisiana's elections are among the safest in the nation, and this endorsement of Representative Miguez's legislation by a supermajority of members in both houses only serves to help further protect Louisiana's ballot from outside influences," said Secretary of State Kyle Ardoin. "I thank Representative Miguez for his diligence in bringing this opportunity for Louisiana's citizens to decide this crucial issue once and for all!"

- · HB 216 by Rep. Dodie Horton to allow for military members and their dependents stationed in Louisiana to serve as election commissioners.
- HB 174 by Rep. Julie Emerson to protect the personal, identifiable information of active duty military members and their dependents from being released in a public records request.

The legislative session begins on April 10 and ends on June 8.

I. PHILOSOPHY

Employees of the State of Louisiana deserve to be treated with respect and dignity, and to work in a professional environment free of harassment and discrimination. The Louisiana Department of State is committed to providing its employees a work environment free from inappropriate and offensive behavior of a sexual nature. To accomplish this, DOS has formulated this policy to define sexual harassment and conduct of a sexual nature that is prohibited in the workplace, and the procedure for effectively reporting such conduct. Employees should realize that the behavior proscribed by this policy includes words and conduct that are inappropriate, offensive or create a hostile working environment. As such, any behavior of a sexual nature or connotation which negatively impacts the workforce is prohibited even though such behavior may not constitute actionable sexual harassment as defined by law.

Prevention and elimination of sexually inappropriate behavior requires the personal involvement and commitment of every DOS employee. Unless and until management is apprised of its occurrence, corrective action to address such behavior cannot be taken. Through this policy and related training requirements, DOS seeks to reinforce its intolerance of sexually inappropriate behavior, and encourages employees who experience, observe, or are informed of such behavior to promptly initiate the reporting process set forth in this policy. Employees can be assured that DOS will objectively and thoroughly investigate reports; implement preventive measures to protect against recurrence; impose corrective action to address violations; and protect complainants and individuals involved in the investigative process from any form of harassment, reprisal, or retaliation.

II. PURPOSE

All DOS employees have a right to a work environment free of harassment and discrimination. For this reason, employees must refrain from offensive and inappropriate conduct, especially of a sexual nature, within the workplace. Managers and supervisors

are responsible for disseminating and discussing this policy with subordinates and ensuring that the workplace is free of such behavior.

Through this policy and the mandatory associated training required for all employees, the DOS seeks to:

- Unequivocally state intolerance for sexually inappropriate behavior
- Identify the scope of such prohibited behavior
- Establish an effective, uniform reporting process
- Require prompt action to protect against recurrence of the prohibited behavior
- Ensure resolution that imposes appropriate corrective action
- Protect complainants and individuals involved in the investigative process from harassment, reprisal, or retaliation
- Respect confidentiality and the privacy rights of employees

III. APPLICABILITY

This policy applies to all DOS employees regardless of rank or status. This includes classified and unclassified employees, full time, part time, seasonal and temporary employees. The tenets of this policy are equally applicable to appointing authorities, executive management, administrators, directors, managers, supervisors, staff members, student workers, and interns.

This policy also applies to non-employees, including visitors and individuals who transact business with DOS such as vendors, maintenance personnel, clients, contractors, and consultants. These non-employees are prohibited from engaging in the behaviors prohibited in this policy and are also protected from experiencing such behavior by DOS employees.

This policy applies not only to the customary workplace and work locations where DOS employees may be assigned, but also prohibits such behavior while traveling for work, while attending conference or off-site meetings, workshops, training, business trips, and business related social events. In addition, this policy applies to off-duty, off-premises behaviors which has an impact on and a relation back to the workplace.

IV. PROHIBITED CONDUCT

Sexually inappropriate behavior proscribed by this policy can take many forms, including unwelcomed sexual advances, requests for sexual favors and other verbal or physical conduct of a sexual nature. Such inappropriate behavior may be by a person of either gender against a person of the same or opposite gender. Such behavior may include conduct of a supervisor, manager or administrator towards a subordinate employee, or conduct by one employee towards another employee of equal or greater rank. It may also include words or conduct by a vendor, contractor, client or visitor to DOS. Finally, an employee may be the victim of inappropriate behavior even though not the target of such behavior.

Sexual harassment, a form of prohibited discrimination, is defined by the Equal Employment Opportunity Commission (EEOC) as unsolicited and unwelcomed sexual

advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature wherein:

- A) Submission to such conduct is explicitly/implicitly a term or condition of employment; or
- B) Submission to or rejection of such conduct is used as a basis for employment decisions (i.e. continued employment, evaluations, wages, advancements, assigned duties, shifts, training opportunities, or any other condition of employment or career development); or
- C) Such conduct has the purpose or effect of unreasonably interfering with an individual's work performance or creating an intimidating, hostile or offensive work environment.

Inappropriate, unacceptable words or conduct which may constitute sexual harassment could be verbal, non-verbal, or physical. Examples include, but are not limited to, the following:

- A) Unwelcomed sexual flirtations, advances or propositions;
- B) Unwelcomed request for sexual favors;
- C) Unwelcomed sexual teasing, jokes, remarks, insults, innuendo or inquiries;
- D) Unwelcomed physical contact (i.e. touching, rubbing, leaning over, pinching, invading another's space by leaning over, purposefully cornering, or blocking passage);
- E) Unwelcomed sexual looks or gestures;
- F) Verbal, written or physical abuse of a sexual nature;
- G) Graphic verbal or sexual comments about an individual or to describe an individual's appearance;
- H) Degrading words and demeaning or inappropriate terms (i.e. referring to a person as Babe, Honey, etc.);
- I) Sexually insulting noises:
- J) Using crude and offensive language;
- K) Discussing sexual activities, or exploits;
- L) Inappropriate commenting on a person's attributes; and/or
- M) Displaying sexually suggestive objects, statements, graffiti, books, magazines, photographs, cartoons or pictures.
- N) Unwelcomed repeated requests for dates or social engagement

NOTE: Employees must be reminded that the verbal and physical behavior proscribed by this policy is always inappropriate in the workplace and hence, violates departmental policy, although such behavior may not be actionable in a court of law as a civil action for sexual harassment. DOS prohibits all sexually inappropriate behavior, regardless of severity, pervasiveness, or identifiable impact.

V. REPORTING PROCEDURE

Early reporting of sexually inappropriate behavior enhances the credibility of the complainant and facilitates the investigative process. DOS does not require a fixed reporting time or deadline—the sooner the better is preferred and immediately reporting is ideal. The initial report need only convey the occurrence of words or actions that are offensive and need not provide detailed information. This report can be verbal (in person

or via telephone) or in writing (letter, memo, email, text) and need not utilize a specific form.

Any employee experiencing, witnessing or having knowledge, directly or indirectly, of sexually inappropriate behavior by anyone or towards anyone associated with DOS or on department premises, including any administrator, manager, supervisor, co-worker, vendor, client or visitor, should immediately report the occurrence. Any such complaint may be made verbally or in writing. Under most circumstances, complaints should be made by the employee to his/her supervisor. If the complaint involves the employee's supervisor or someone within the direct line of supervision, or if the employee, for any reason, is uncomfortable reporting such behavior to a supervisor, he/she may report the incident to another supervisor or manager, or directly contact the Human Resources Director at Post Office Box 94125, Baton Rouge, Louisiana 70804-9125 or (225) 925-4696.

VI. INVESTIGATION OF COMPLAINT

- A) All reports of sexually inappropriate behavior will ultimately be reported to the Human Resources Director who generally will direct the investigative process. Management personnel in a need to know capacity will be apprised of the complaint.
- B) DOS will investigate **all** complaints. "Informal" complaints or requests to withhold investigation (unless or until a future occurrence) will be treated the same as a formal complaint and investigated immediately.
- C) To prevent further occurrences or to preserve the integrity of the investigation, temporary reassignment, transfers, forced leave or other personnel actions permissible under the Civil Service Rules may be utilized.
- D) The investigation will be thorough and include interviews with the complainant, the accused, witnesses and other individuals possessing relevant information. Records, logs, reports, photos, or other documentation pertinent to the complaint will be reviewed.
- E) The investigative process will be memorialized, thus requiring that all involved prepare written statements or provide verbal statements that will be recorded.
- F) Persons called upon to participate in the investigation are required to answer all questions truthfully and cooperatively. Employees do not have the option of remaining silent or declining to be involved.
- G) The investigative process will be conducted expeditiously and professionally, with appropriate emphasis on the rights of all involved.
- H) To the extent allowed by law, the investigative process will be conducted in a confidential manner, with only those in a need-to-know position involved. Employees who are called on to participate will be instructed that the complaint and all information provided during the investigation are to remain confidential.

I) Upon completion of the investigation, the Human Resources Director will apprise management of the outcome and recommendations for resolution. The complaining employee and accused will be apprised of the outcome of the investigation, with appropriate emphasis on the rights of all involved.

VII. COMPLAINT RESOLUTION

- A) Any employee found, after appropriate investigation, to have engaged in sexually inappropriate behavior will be disciplined in accordance with applicable law and the Civil Service Rules. Such action may include counseling, reprimand, suspension, demotion, reduction in pay or termination.
- B) In addition to corrective action, other appropriate measures, including follow-up inquiries and re-training, will be utilized to ensure that the inappropriate behavior does not recur.
- C) Regardless of the outcome, the complainant has the option of pursuing a claim under state or federal law. Initiation of such a claim is not dependent upon the outcome nor completion of the DOS's administrative investigation.

VIII. NON-RETALIATION

- A) Any employee making a good faith complaint of sexually inappropriate behavior will be protected from retaliation, reprisal and harassment. Likewise, any employee providing information or otherwise participating in the investigation of such a complaint will be protected from retaliation, reprisal and harassment.
- B) If a complaint is made and the investigation reveals that retaliation, reprisal or harassment has occurred against a complaining employee or anyone participating in the investigative process appropriate, severe disciplinary action will be taken, including the possibility of termination.

IX. TRAINING

DOS recognizes that implementation of a policy prohibiting sexually inappropriate behavior in the workplace alone is insufficient to prevent and address such behavior. To support this policy and encourage a culture where employees willingly report concerns, DOS requires all employees to successfully complete training on this topic upon hire and on a continuing basis thereafter. At a minimum, DOS requires the following training for its employees:

- Upon hire, all new employees must complete the agency onboarding process which contains a copy of this policy and covers the contents of the policy in detail. Supervisors are required to ensure that the onboarding process is completed within 30 days of hire thereby insuring that the new employee has reviewed the contents of this policy.
- Within 30 days of hiring, all new employees are required to complete the most recent CPTP training course on sexual harassment. Certification of successful completion will be documented through CPTP.
- On an annual basis, all employees are required to complete the most recent CPTP training course on sexual harassment. Certification of successful completion will

be documented through CPTP.

• Within 30 days of attaining a supervisory position, all new supervisors are required to complete the most recent CPTP training on sexual harassment designated for supervisory personnel. This training, which emphasizes identifying, preventing, and responding to sexually inappropriate behavior, is thereafter to be completed on an annual basis. Certification of successful completion will be documented through CPTP.

X. FEDERAL AND STATE LAWS

This policy establishes a procedure to administratively report and address complaints of sexually inappropriate behavior. This policy is intended to supplement rather than replace or supersede the private and/or statutory procedures regarding sexually inappropriate workplace behavior available to employees under state and federal law, including Title VII of the Civil Rights Act and La. R.S. 23:331 et seq. Employees should be aware that there are certain procedures and time delays, including the filing of a complaint with the Equal Employment Opportunity Commission (EEOC) or the Louisiana Commission on Human Rights (LCHR), which must be satisfied prior to initiating civil litigation regarding inappropriate workplace sexual behavior.

XI. VIOLATIONS

Any employee, regardless of rank or status, found to have violated the prohibitions of this policy will be subject to disciplinary action, up to and including termination. After investigation and satisfaction of due process requirements, corrective action may be imposed for the following:

- Failure to comply with mandatory training requirements
- Failure by a supervisor or manager to timely report a complaint of sexually inappropriate behavior
- Failure to participate in or cooperate with the investigative process
- Providing false information or withholding information during questioning
- Filing a false, malicious, or frivolous complaint
- Harassment, reprisal, or retaliation towards a complainant or anyone involved in the investigative process

Any employee, regardless of rank or status, who intentionally fails to properly and timely report sexually inappropriate workplace behavior will be subject to disciplinary action, up to and including termination.

Any employee found to have intentionally or maliciously falsely accused another of sexually inappropriate workplace behavior will be subject to disciplinary action, up to and including termination. This prohibition is not intended to discourage employees from filing good faith complaints of behavior proscribed by this policy.

XII. PERSONAL LIABILITY

An Individual experiencing sexually inappropriate behavior in the workplace has the right to initiate civil litigation under state or federal law. When this occurs, as an employer, the State of Louisiana may be cast in judgement or a settlement of claims may be negotiated to avoid the risk of litigation. In either event, the financial burden falls upon the taxpayers of the State of Louisiana.

To reduce this impact, upon determination that an employee has engaged in sexually inappropriate workplace behavior, La. R.S. 42:351 mandates that consideration be given to requiring that the employee reimburse all or a portion of any judgment or settlement that may result from a claim or civil litigation. The process and factors to be considered in making this determination are set forth in La. R.S. 42:353, which also authorizes the Attorney General to file suit against an employee to enforce the state's right to reimbursement and indemnification.

Accordingly, Department of State employees are hereby placed on notice that dire consequences, in the nature of employment sanctions and personal financial liability, may result from any violation of the prohibitions and requirements of this policy.

XIII. QUESTIONS/COMMENTS

This policy shall remain available to employees for review at all times on the DOS intranet site. Notices related to workplace harassment and discrimination are conspicuously posted at DOS work locations throughout the state.

Questions or comments concerning sexual harassment, sexually inappropriate behavior or the interpretation or enforcement of this policy should be addressed to the Human Resources Director. To the extent possible, such inquiries will be maintained in strict confidence. Employees are reminded that complaints will be appropriately investigated notwithstanding the employee's request that no action be taken or that the investigative process be delayed.
